# Conditions of participation in the SNIPES Soundbooth activation with Aitch

#### 1. ORGANI7FR

The organizer of the "SNIPES Soundbooth Activation with Aitch" is SNIPES SE, Schanzenstraße 41, D-51063 Cologne and is hereinafter referred to as the "Organizer" or "SNIPES".

Participation in the competition is free of charge. The participant accepts the following conditions of participation:

#### 2.ELIGIBILITY

Natural persons who are at least 18 years old and permanent residents in Germany, Austria, Switzerland, the Netherlands or France may participate in the competition. The winners themselves are responsible for the accuracy of the data and contact details provided. In the event of a breach of the conditions of participation, SNIPES reserves the right to exclude the persons concerned from the prize. Travel by Deutsche Bahn and accommodation costs of €200 for one night are included. SNIPES will in close cooperation with the prospective winner undertake the booking of the lodging and travel.

The prize cannot be paid out in cash and cannot be exchanged. The prize cannot be transferred to third parties.

#### 4. PARTICIPATION

The activation will take place between 22.07.2024 and 28.07.2024 on the SNIPES TikTok Channel (https://www.tiktok.com/@snipesknows). The challenge ends on 28.07.2024 at 23:59h.

#### 4.1 Participation requirements

Participants must rap to a beat provided by SNIPES. They must then publish the recording on their personal TikTok user profiles using the hashtags #aitchxsoundbooth2024. This can take

the form of a "duet", "stitch" or their own video. Their personal user profiles must be publicly viewable. The post must remain available on their profiles up to and including January 2025. In addition, participants have the opportunity to record their part in one of the SNIPES Soundbooths and post their part on TikTok. In order to redeem the prize, the winner must provide SNIPES with their first and last name, address, e-mail address and date of birth by 09.08.2024 at 23:59am at the latest. Otherwise or if the drawn person doesn't comply to the instructions given by SNIPES, SNIPES reserves the right to draw a new winner.

#### 6. SOCIAL MEDIA CONTENT AND RIGHTS

During the all-day recording session in the SNIPES Studio44 (Karl-Marx-Straße 97-99, 12043 Berlin) and the one-hour private shopping tour in the SNIPES Store (Karl-Marx-Straße 97-99, 12043 Berlin), SNIPES will have image, sound and video material produced independently or by third parties and use it commercially. The participants may be seen in such recordings. The consent of the participants is already deemed to have been irrevocably granted and does not need to be obtained separately. The participant agrees to grant SNIPES and commissioned third parties a worldwide, unlimited, non-exclusive right to use his/her submission and the song produced on it. The participant agrees that third parties, artists selected by SNIPES, may also use his/her submission on TikTok within the scope of this agreement, within the meaning of sections §§ 16 ff. UrhG. The participant declares that he/she knows and agrees that SNIPES and authorized third parties will use his/her submissions commercially for advertising purposes. The participant is aware that he/she will not be remunerated separately for this.

#### 7. CANCELLATION

SNIPES reserves the right to cancel the competition at any time without prior notice for important reasons. Cancellation for good cause may occur in particular if the proper execution of the production//competition can no longer be guaranteed for technical or legal reasons. Liability towards participants is excluded in this respect. If such a termination was caused by the intentional behavior of a participant, SNIPES may demand compensation from this person for the resulting damage.
